Terms and Conditions for the use of the websites of State Enterprise Bulgarian Sports Totalizator (BST)

Please read these Terms and Conditions carefully before using the Site. These Terms and Conditions constitute a CONTRACT between you as a USER and BST, granting you the right to use the services of the Site free of charge for personal and non-commercial purposes, subject to the terms and conditions below. By accessing (loading) the website, you agree to be bound by these Terms and Conditions and any subsequent changes to them, and agree to comply with them. If you do not agree to all of the terms and conditions below, please do not use this website and the services and modules provided on this website. BST has created these rules and guiding principles for the sole purpose of protecting you and ensuring that you have a safe, enjoyable and useful time visiting this site.

I. Basic concepts

For the purposes of these Terms and Conditions, the following terms are used with the following meanings:

USER means any individual who uses any of the services on the site. A USER of this website does not have the rights and obligations of a participant in the gambling games organised by BST, unless he/she also has the capacity of a participant within the meaning of the Gambling Act and the General and Mandatory Gaming Conditions and Rules for the organisation and conduct of the gambling games organised by BST;

SERVICE/s on the site include:

- Access to the information resources/data on the site provided via a web browser;
- Participation in the site's forums;
- Creation and personalization of user profiles through registration, which enables access to the information resources of the site or participation in Internet games developed specifically;

THIRD PARTY MALFUNCTIONS are actions or inactions of third parties that are contrary to the rules of Internet ethics, including but not limited to DoS (Denial of Service), server hacking, defacement, data theft, etc.

II. Acceptance of the Terms and Conditions of Use

These Terms and Conditions are binding only in the relationship between the USER of the services of the site and BST.

Each USER is granted the right to use the services of the site for personal/non-commercial purposes only.

When posting a review/comment in the forums, the USER agrees to abide by the rules posted there for posting comments. BST is not responsible for the opinions expressed by USER.

III. Protected Rights

BST is a data controller registered under the Data Protection Act.
